Explanation: Ayush Ministry launched the campaign "AYUSH AAPKE DWAR" from more than 45 locations across the country today.

Dr. Munjapara Mahendrabhai, Minister of State, for Ayush launched the campaign from Ayush Bhawan by distributing medicinal plants to staff. On this occasion, Dr. Munjapara addressed the gathering and appealed to adopt medicinal plants and take care of these as a part of their family. Total 21 states are participating in the launch activities today in which more than 2 lakh saplings will be distributed. Minister of Ayush, Shri Sarbananda Sonowal will also launch this campaign from Mumbai. The campaign aims to distribute medicinal plant saplings to 75 lakh households across the country in one year. The medicinal plants include Tejpatta, Stevia, Ashoka, Jatamansi, Giloy/Guduchi, Ashwagandha, Kumari, Shatavari, Lemongrass, Guggulu, Tulsi, Sarpagandha, Kalmegh, Brahmi and Amla.

The DTTI was established out of the need to transform the bilateral Defence relationship between both nations and also strengthen India's Defence base. Under DTTI, Joint Working Groups on land, air, naval, and aircraft carrier technologies have been established to focus on mutually agreed projects in respective domains.

Project Agreement (PA) for Air-Launched Unmanned Aerial Vehicle (ALUAV) under the Joint Working Group Air Systems in the Defence Technology and Trade Initiative (DTTI) signed between India and the US. The Project Agreement (PA) for Air-Launched Unmanned Aerial Vehicle (ALUAV) comes under the Research, Development, Testing, and Evaluation (RDT&E) Memorandum of Agreement between the Ministry of Defence and the US Department of Defence.

The historic milestone was achieved after a previous attempt failed. The sample, collected from a rock dubbed "Rochette", by members of the Perseverance mission team, was collected after drilling for over half-a-kilometer. This was perseverance's second attempt at collecting a sample to be sent home. The first attempt was made on Aug. 5, but the rock it was drilling into was too soft and crumbled in bits that couldn't be fit into the collection tube.

The Indian Navy was represented by Guided Missile Destroyer INS Ranvijay with a ship borne helicopter, ASW Corvette INS Kiltan and Guided Missile Corvette INS Kora and one P8I Long Range Maritime Patrol Aircraft. Participants from the RSN included one Formidable Class Frigate, RSS Steadfast, embarked with an S-70B naval helicopter, one Victory Class Missile Corvette, RSS Vigour, one Archer Class Submarine and one Fokker-50



Maritime Patrol Aircraft. Four F-16 fighter aircraft of the Republic of Singapore Air Force (RSAF) also participated in the exercise during the Air Defence Drills.

This Symbex was started in 1994. This is the longest continuous bilateral naval exercise of the Indian Navy with a foreign navy.

The EVCS are being developed under Faster Adoption and Manufacturing of (Hybrid) & Electric Vehicles (FAME) India Scheme Phase-II. Under this scheme, POWERGRID shall be developing 11 EVCS in Shillong city (5 Public EVCS and 6 at government establishments).

POWERGRID has developed itself as one of the market leaders in the EVCS business and has its presence in major cities of India like Hyderabad, Ahmedabad, Delhi, Bengaluru, Gurugram, and Kochi.
